## POSITION OVERVIEW

The Treasury Associate will be responsible for all credit needs for the *L Catterton* Funds and be influential in the continued growth in Treasury. The Treasury Associate will be based in Greenwich, CT and work closely with the firm's Global Treasurer and Finance team and would have exposure to other teams within the organization.

## RESPONSIBILITIES

Responsibilities include, but are not limited to the following:

- Primary oversight for all fund and SPV level financing arrangements for all L Catterton Funds
- Act as point of contact for 30+ L Catterton bank relationships and specialty lenders
- Ongoing monitoring of L Catterton loans; in particular, staying up to date with market conditions to ensure optimal pricing, flexibility, and enhancements
- Maintain the firm's loan portfolio, including management of borrowing/ paydown requests, delivering information and compliance necessities, tracking and reporting all credit exposure, internal reporting and monitoring of utilization, future capacity needs
- Assist in funding for deal closings and other deal-related transactions, including borrowings and delivery of funds timely
- Explore and evaluate potential banking partners for any lending opportunities
- Work closely with regional teams to ensure best practices and updates within Treasury are being communicated and incorporated as appropriate
- Assist the Treasury function in other areas of need, both operational and administrative
- Support ongoing improvement, implementation, modification, and integration of internal systems related to Treasury

## QUALIFICATIONS

- 2-4 years of experience in a similar/related role at a financial institution or alternative investment firm
- Experience dealing with banks, preferably in subscription finance and corporate banking markets
- Proficient in MS Office suite skills, especially Excel and Powerpoint, as well as Power BI
- Previous experience using a TMS, especially Kyriba is a plus
- Strong attention to detail, accuracy and follow-up
- Superior interpersonal skills, proven ability to develop relationships and work with a diverse group including internal and external constituencies
- Highly developed written and verbal communications skills
- Ability to work well under pressure, manage multiple assignments and personnel, prioritize workload and maintain composure under pressure; take initiative and possess a business-orientated, entrepreneurial mind set
